# Methodology

- Eligible CLOs are those that went effective before 31 December 2022, and were still within their reinvestment period at that date
- New CLOs are those that went effective after 31 December 2021
- Best CLO manager categories are calculated using the average ranks of all a managers' CLOs of that CLO type
- US boutique manager is defined as a manager with four or fewer eligible US BSL CLOs under management
- European boutique manager is defined as a manager with four or fewer eligible European CLOs under management
- Non-traditional CLOs include bond-flex CLOs, triple-C flex CLOs and sectorspecific CLOs
- The redeemed CLO categories include all CLOs with a redemption date between 1 January 2022 and 31 December 2022
- Open-ended CLO funds listed on Creditflux's hedge fund website launched before 2022 are eligible, and ranked by a blend of total returns, liquidity and sorting ratio
- Best private closed-end funds are closed-ended CLO funds that are not publicly listed and have full 2022 coverage, ranked by IRR
- Best public closed-end funds are closed-ended CLO funds that are publicly listed launched before 2022, ranked by NAV per share calculations
